President's Message by Tom Elliott

Dear Friends and Neighbors,

This has been a difficult year for all of us and a challenge to stay safe, and at the same time to make the most of positive opportunities! One of the best opportunities is to get outdoors and enjoy the many open space benefits of this great community and region.

Much has happened with our Land Trust this past year:

- The Town of Westbrook is in the process of purchasing a key 146 acre parcel of open space known as Toby Hill VIII which will tie several open space parcels together in the northeast corner of town, including two large WLCT properties. In our commitment to this effort, the Land Trust proposed a matching challenge and raised \$2,620.
- In September, the Land Trust participated in the International Coastal Cleanup.
 22 volunteers cleaned West Beach (1.5 miles), Coral Sands Beach (.3 miles) and Kirtland Landing (.2 miles). We gathered 8 full Garbage bags!
- On the regional level, our Land Trust has joined other Land Trusts to form the new LCRLT (Lower Connecticut River Land Trust) to facilitate regional initiatives.

I want to thank the Residents of Westbrook for their continued support of the Westbrook Land Conservation Trust.



Land Parcel Spotlight: Timberlane and Toby Hill Chase Connection

The Timberland Drive and Toby Hill Chase properties are the Trust's largest properties, and both have trails that connect! The parcels were acquired in 2006 as part of a town regulation requiring the designation of open space in subdivisions. Timberland Drive consists of 15 acres that includes wetland, hilly forest and Trout Brook, and can be accessed from Lake Louise Drive, off Timberlane Drive. Toby Hill Chase is 26 acres of upland forest on Autumn Ridge, off Toby Hill Rd. There is a marked trail starting from either property that takes you on about a one mile walk through mature forests, cedars and over a bridge crossing Trout Brook. If you are looking for an extended hike or bike ride, you could exit the trail to Lake Louise, turn right on Timberlane Drive, head south on Route 153, then enter the Preserve off Rt 153. The Trust's 41 acres combined help to protect our natural resources, provide an excellent opportunity for outdoor recreation, and are an important part of the town's plan of development that envisions a greenway creating a corridor of connected open space. If the town can purchase the abutting 146.47 acre forested Toby Hill VIII land, a large gap would be filled in the continuation of the McVeagh Greenway, envisioned in the Town's Plan of Conservation and Development, in northeast Westbrook. In the illustration below, you can see the Trust properties near the center bottom, and the access roads. The proposed open space acquisition is outlined. Note Trout Brook.

International Coastal Cleanup - 4th Year of WLCT Participation

On Saturday, September 26, 2020, the Trust participated again in **International Coastal Cleanup Day** at the Town Beach. 22 volunteers from around the state showed up!! They were dispersed to a variety of beaches to help clean. This effort began more than 30 years ago. Now, volunteers from states and territories across the U.S., and more than 100 countries come together each year to participate. Ocean trash affects the health of wildlife, people, and local economies. The WLCT owns several properties that encompass tidal wetlands and creeks - fragile habitat vital to coastal marine life, and we are responsible for stewarding these properties, such as the Seaside Avenue tidal wetland, below.



Who am I?

I am considered a vulnerable species because my population is declining. My species has existed nearly unchanged for at least 445 million years, well before even dinosaurs existed. You might see my kind en masse, spawning in shallow waters at the beach during spring high tides around full or new moons. I'm important because:

- 1. I release hundreds of thousands of eggs during spawning providing valuable nutrition to migrating birds and fish and other sea creatures
- 2. My blood contains a clotting agent, Limulus Amebocyte Lysate, or LAL, which clots in the presence of certain groups of bacteria. The FDA requires the use of LAL to test all injectable and intravenous drugs produced in the U.S before they are used in patients to make sure they are sterile...I'm a horseshoe crab!!! If you see me on my back, pick me up (holding both sides of my shell, never my tail) and release me back into the water.
